ORDERSubject: Inspection of Training Institutes – NIS Sparta Limited.

Further to the inspection carried out by officers of the Authority at your training centre premises at Agra, Bhiwani, Haridwar, Kanpur, Lucknow and Meerut from 19th to 24th April, 2004 followed by notice dated 13th May, 2004 and the enquiry proceedings on the subject of irregularities observed at the above training institutions, Authority issues the following instructions in consideration of the submissions made by your company during the course of the enquiry proceedings, meetings with the undersigned and your letter of 8th June, 2004:

1. Your training centres at Agra, Bhiwani, Haridwar, Kanpur, Lucknow and Meerut stand terminated with immediate effect. These training centres shall be excluded from the list of centres at Annexure-I submitted along with your letter dated 8th June, 2004.
2. You are permitted to carry on the training programme at your other centres listed in Annexure-1&2 of your letter dated 8th June, 2004 subject to converting these centres into Mother training centres in tune with the terms and conditions of approval of the Authority.
3. The time limit granted to you for conversion of these centres into mother centres is 40 days for centres mentioned at Annexure-1 and 60 days for centres mentioned at Annexure-2. The time limit of 40 days and 60 days respectively will commence on 15th June, 2004.
4. The approval of all other training centres (except the training centres mentioned at Annexure-1&2 of your letter dated 8th June, 2004) stands withdrawn. This withdrawal does not pertain to your seven mother centres namely, Mumbai, Bangalore, Chennai, two at Kolkata and two at New Delhi.
5. Please declare on record that you do not have any other franchise arrangements with any other training centres or institutes and that the franchise arrangements at the centres mentioned in Annexure-1&2 shall stand terminated within the stipulated schedule of 40-60 days.
6. A standard agreement containing fundamental and procedural aspects of the training shall be furnished to you shortly for your signatures and execution.
7. You shall advise the authority one week in advance of the training programme undertaken by your training centres about:-
 - a) the duration of the training;
 - b) the timings of the training;
 - c) the company which has sponsored the trainees for which you are organizing the training;
 - d) the number of candidates receiving the training; and
 - e) the date decided for the examination.
8. You shall file with us a report of the training soon after the conclusion of the training programme.
